Soil probes and related administration, such as probe and percolation test reports, and existing system inspections will be billed on a time and materials basis at the following rates:

Developer will be responsible for preparing the percolation test holes and providing water for the percolation tests.

All billing will be sent to the Municipality on invoices noting the date, type of service performed, who performed the service, the time involved (when pertinent) and the cost. Each invoice will contain a note to the Municipality to bill the developer to reimburse the Municipality.

Design services, land development consulting, or SEO services performed by the Alternate Sewage Enforcement Officer will be invoiced to the Township by him and paid directly to Charles F. Herr, Jr.
